On June 19, 1865, nearly two years after President Abraham Lincoln emancipated enslaved Africans in America, Union troops arrived in Galveston Bay, Texas, with news of freedom. More than 250,000 African Americans embraced freedom by executive decree in what became known as Juneteenth or Freedom Day. With the principles of self-determination, citizenship, and democracy magnifying their hopes and dreams, those Texans held fast to the promise of true liberty for all.

June is Pride Month

Pride month started as a riot against police brutality at a small dive bar in New York City called the Stonewall Inn. At the time there existed outdated “masquerade” or “cross-dressing” laws that suggested a “man” or a “woman” must be wearing a certain number of clothing items that matched the gender on their state-issued ID. The police took advantage of these laws to raid drinking establishments and arrest transgender and gender non-conforming individuals. Just after midnight on June 28, 1969, the police raided the Stonewall Inn like they had many times before. Only, this time, something unusual happened: Stonewall patrons fought back.

On June 28, 1970, on the one year anniversary of the Stonewall Uprising, the first Pride marches were held in New York, Los Angeles and Chicago. Thousands of LGBT+ people gathered to commemorate Stonewall and demonstrate for equal rights. The events of Stonewall and the liberation movements that followed were a direct result of prior decades of LGBT+ activism and organizing. In particular, Pride traditions were adapted from the "Reminder Day Pickets" held annually (1965-1969) on July 4 at Independence Hall in Philadelphia, Pennsylvania.

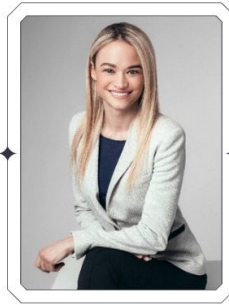
